**BILLY EARL LOLLIS AND CAROLYN R. LOLLIS**

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Seventy-Five Hundred and No/100**

**DOLLARS (\$ 7500.00**), with interest thereon from date at the rate of **Six (6%)** per centum per annum, said principal and interest to be repaid in monthly instalments of

**Fifty-Four and No/100** Dollars (**\$ 54.00**) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the southern side of Arthur Avenue, said property being designated as # 25 Arthur Avenue, in the City of Greenville, and also being shown as Lot 18 of Block O on plat of property of O. P. Mills, recorded in Plat Book F at page 299, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the South side of Arthur Avenue, at the joint front corner of Lots 17 and 18 of Block O, and running thence with the line of Lot 17, S. 24 E. 192.8 feet to an iron pin; thence N. 70-39 E. 59 feet to an iron pin at corner of Lot 19; thence with the line of Lot 19, N. 23- 36 W. 196.6 feet to an iron pin on the South side of Arthur Avenue; thence with the South side of Arthur Avenue, S. 67-06 W. 60 feet to the Beginning corner.

Being the same property conveyed to the Mortgagors by deed of Fidelity Federal Savings & Loan Assn., to be recorded herewith.

This mortgage is given to secure the unpaid portion of the purchase price.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
