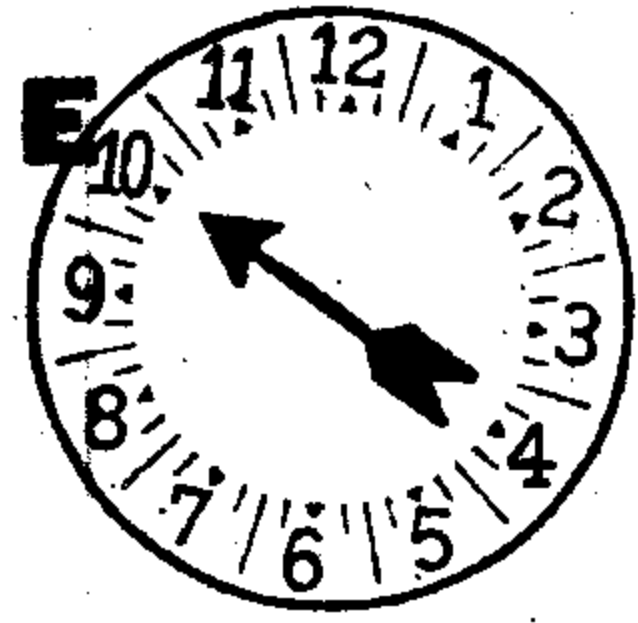

All that piece, parcel of land situate, lying and being in the County of Greenville, State of South Carolina, bounded by lands of J. J. Gentry, S. F. Barton, Robert Parker, et al. Beginning on a Sourwood Tree and running thence South 35 1/4 West 31.50 to a stone in the place of a Chestnut; thence South 18 East 10.50 to a Black Oak; thence North 55 East 22.36 to Red Oak; thence North 28 East 27 1/2 to rock; thence North 87 1/2 West 17.32 to the Beginning, containing 64 acres more or less.
