MARY EVA MOORE BENBOW (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty Thousand and No/100 ----- DOLLARS (\$ 20,000.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid in monthly instalments of One Hundred Forty-four and No/100 --- Dollars (\$ 144.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the northeastern side of Corrine Drive in the City of Greenville, being shown as Lot 77, Block F, on plat of University Heights, recorded in Plat Book BB, Page 21, and described as follows:

BEGINNING at an iron pin on the northeastern side of Corrine Drive at joint front corner of Lots 77 and 78 and running thence N. 56-37 E. 205.8 feet to pin; thence S. 32-07 E. 101.9 feet more or less to pin; thence with line of Lot 74 S. 56-37 W. 207.5 feet to iron pin on the northeastern side of Corrine Drive; thence with the northeastern side of Corrine Drive N. 31-13 W. 101.9 feet to beginning corner.
