ALL that piece, parcel or lot of land in Fairview Township, Greenville County, State of South Carolina, containing one (1) acre, more or less, and being designated as a portion of tracts Nos. 2 and 3 of the property of The First Carolinas Joint Stock Land Bank of Columbia, a plat of which is recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book N, Page 7, and having, according to a survey thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book UU, Page 49, with the following metes and bounds to-wit:
