TO ALL WHOM THESE PRESENTS MAY CONCERN: I, R. H. Harris of Greenville County

----- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto The Pelzer-Williamston Bank

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Five Hundred thirty-two and 49/100

----- DOLLARS (\$ 532.49 ),  
due and payable \$45.00 (Forty-five) each month beginning January 16, 1961 and continuing for each consecutive month until paid in full

with interest thereon from ~~the~~ maturity at the rate of 6 per centum per annum, to be paid: ~~in~~ monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee; and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns: "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oaklawn Township, containing one acre, more or less, adjoining lands of Alvin Davis, C. H. Bennett, James and T. H. Martin and others, being on the East side of Highway number 29, and having the following courses and distances to wit:

BEGINNING at a point in the center of Old Greenville road, and running thence North 36 1/2 West 1 chain 41 links to line of Alvin Davis; thence along line of Alvin Davis S - 39-1/4-W 0.50 to an angle; thence S-57 1/2 W - 0.50 to an angle, thence S 73 1/2 - W 1.53 to center of Highway No. 29; thence along center of Highway No. 29 - S - 4.00 W 4.00 to intersection of Old Greenville road, thence along Old Greenville road N-38 1/2 E 5.24 to beginning corner.

This being that same lot of land conveyed to me by Mrs. C. H. Massey, by her deed dated May 19, 1947 and recorded in the R. M. C. office for Greenville County in Vol. 313, at page 10.

Together with all and singular the rights, members, hereditaments and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
