(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Three Thousand and No/100 -----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 41 of Augusta Road Hills, plat of which is recorded in Plat Book M, Page 33, and described as follows:

BEGINNING at an iron pin on the southeastern side of Cammer Avenue joint front corner of Lots 41 and 42 which pin is 291.4 feet from the intersection of Low Hill Street and Cammer Avenue, and running thence S. 47-50 E. 165 feet to pin; thence S. 42-10 W. 60 feet to the pin at corner of Lot 40; thence with the line of Lot 40 N. 47-50 W. 165 feet to pin on Cammer Avenue; thence with the southeastern side of Cammer Avenue N. 42-10 E. 60 feet to point of beginning.

Being the same premises conveyed to the mortgagor by deed recorded in deed Book 398, Page 116.
