TO ALL WHOM THESE PRESENTS MAY CONCERN:

MOONVILLE METHODIST CHURCH  
(FORMERLY AUGUSTA ROAD  
METHODIST CHURCH)

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Seventeen Thousand and No/100** -----

DOLLARS (\$ 17,000.00 ), with interest thereon from date at the rate of **six (6%)** per centum per annum, said principal and interest to be repaid in monthly instalments of **One Hundred Sixty-nine and No/100** ---- Dollars (\$ 169.00 ) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, on the east side of South Airbase Drive and on the south side of Flora Louise Drive, and having the following metes and bounds, according to survey by C. O. Riddle, surveyor, August 29, 1956, as follows:

BEGINNING at the southeastern intersection of said drives and running thence with the southern side of Flora Louise Drive S. 68-45 E. 299.1 feet to a point on said drive; thence S. 8-15 W. 299.1 feet to a point; thence N. 68-45 W. 299.1 feet to a point on the east side of South Airbase Drive; thence with the eastern side of said South Airbase Drive N. 8-15 E. 299.1 feet to the beginning corner, and containing two acres, more or less.

Being the same property conveyed to the mortgagor under the name of Augusta Road Methodist Church by deed recorded in Deed Book 644, Page 450, in the R. M. C. Office for Greenville County.
