TO ALL WHOM THESE PRESENTS MAY CONCERN:

James Quinton Cox and Jewell Gulley Cox
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Three Thousand Four Hundred and no/100--- DOLLARS (3,400.00----), with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid in monthly instalments of Thirty Five and no/100--- Dollars (\$35.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Eastern side of Watson Street in the City of Greenville, being shown and designated as Lot 14 on plat of the property of Charles Watson and Grace Watson Griffith recorded in Plat Book G at pages 164-165 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the East side of Watson Street, joint front corner of Lots 13 and 14; thence with the line of Lot 13, N. 70-46 E. 114.7 feet to a pin; thence S. 17-55 E. 51 feet to rear corner of Lot 15; thence with the line of Lot 15, S. 70-53 W. 113.9 feet to Watson Street; thence with the Eastern side of Watson Street, N. 18-40 W. 51 feet to the point of beginning.

Being the same property conveyed to the mortgagors by deed recorded in Deed Book 667 at page 79.
