WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 58 and a portion of Lot 57 on a plat of property of the Estate of Tully F. Babb, recorded in Plat Book GG at page 158 and 159, and having according to said plat the following:

BEGINNING at an iron pin on the Western side of Babb Avenue 15.4 feet South of the joint front corner of Lots 57 and 58 and running thence with a new line through Lot 57, S. 83-10 W. 255 feet to an iron pin in line of Lot 57; thence N. 6-50 W. 218 feet to an iron pin on Skyview Drive; thence with said Skyview Drive, S. 82-18 E. 280.9 feet to an iron pin on Babb Avenue; thence with said Babb Avenue, S. 6-06 W. 74.6 feet to an iron pin; thence S. 6-50 E. 75.4 feet to an iron pin, the point of Beginning.

Being the same property conveyed to Mortgagors by deed recorded in Deed Book 644 at page 151.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner, it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate
