# MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

DOROTHY A. WALKER

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Thousand One Hundred and No/100ths

DOLLARS (\$ 7,100.00), with interest thereon from date at the rate of six per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable, August 1, 1979

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns,

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Gantt Township, County of Greenville, State of South Carolina, being known and designated as Lot No. 14 as shown on a plat prepared by J.C. Hill, L.S., dated February 12, 1960, entitled "Property of Otis Davis", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book TT at page 161, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northwestern side of Maurty Street at the joint front corner of Lots Nos. 13 and 14, and running thence with the line of Lot No. 13 N. 20-50 W. 120 feet to an iron pin on the subdivision property line; thence with the subdivision property line N. 69 E. 70 feet to an iron pin; thence continuing with the subdivision property line S. 16-20 E. 120 feet to an iron pin on the Northwestern side of Maurty Street; thence with the Northwestern side of Maurty Street S. 68-10 W. 58.6 feet to the point of beginning.

ALSO:

All that piece, parcel or strip of land adjoining the above described lot on the Easterly side thereof, and having the following metes and bounds:

BEGINNING at an iron pin on the Northwestern side of Maurty Street at the joint front corner of the premises herein described and Lot No. 14 hereinabove described, and running thence with the line of Lot No. 14 N. 16-20 W. 120 feet to a point; thence N. 69-00 E. 5 feet to a point; thence S. 16-20 E. 120 feet to a point on the Northwestern side of Maurty Street; thence with the Northwestern side of Maurty Street S. 68-10 W. 5 feet to the point of beginning.
