, with interest thereon from date  
at the rate of 6% per centum per annum, to be computed and paid Monthly  
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and  
unpaid, the whole amount evidenced by said note to become immediately due, at the option of the  
holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its  
maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity  
it should be deemed by the holder thereof necessary for the protection of his interests to place and

ALL that piece, parcel or lot of land situate, lying and being in the County of  
Greenville, State of South Carolina, on the southern side of Gilstrap Drive and being  
known and designated as Lot No. 14 of Forest View as shown on plat thereof recorded in the  
R. M. C. Office for Greenville County in Plat Book "11", at Page 105 and having,  
according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Gilstrap Drive at the joint front  
corner of Lots Nos. 14 and 15 and running thence along the joint line of said Lots  
S. 10-05 E. 149.7 feet to an iron pin; thence S. 82-08 E. 135 feet to an iron pin;
