TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Robert Sherman Smith and Betty Lovelle Smith, (hereinafter referred to as Mortgagor) SEND(S) GREETING.

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of SIX THOUSAND FIVE HUNDRED

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in-hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, located near Chick Springs, being shown as Lots Nos. 52 and 53 on a plat of property made for G.D. Collier by H.L. Dunahoo, Surveyor, dated October 27, 1947, and having the following courses and distances: BEGINNING on a stake on the south side of Davis Street, joint front corner of Lots Nos. 51 and 52, and runs thence S. 12 E. 215 feet to a stake on the right-of-way of the P. & N. Railway; thence with said right-of-way N. 62-30 E. 52 feet and N. 67-35 E. 52 feet to a stake, corner of lot No. 54; thence with line of that lot N. 12 W. 190 feet to a stake on the south side of Davis Street; thence therewith S. 79 W. 100 feet to the beginning corner, and being all of that property conveyed to us by G.D. Collier by deed to be recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner, it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
