called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of **TEN THOUSAND NINE HUNDRED** Dollars (\$ 10,900.00), with interest from date at the rate of **five and one-fourth** per centum (**5 1/4 %**) per annum until paid, said principal and interest being payable at the office of **the Federal Housing Administration** in **Washington, D. C.**, or at such other place as the holder of the note may designate in writing, in monthly installments of **SIXTY AND 28/100** Dollars (\$ 60.28), commencing on the first day of **December**, 19**61**, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **November**, 19**91**.

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **GREENVILLE**, State of South Carolina:

ALL THAT CERTAIN piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 86 as shown on a plat prepared by C.C. Jones, dated October, 1947, entitled "Woodfields", recorded in the R.M.C. Office for Greenville County in Plat Book S at page 113, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Brook Forest Drive West at the joint front corner of Lots Nos. 85 and 86, and running thence with the line of Lot No. 85 S. 38-20 W. 160 feet to an iron pin in the line of Orders Tract; thence with the line of Orders Tract N. 51-40 W. 80 feet to an iron pin at the joint rear corner of Lots Nos. 86 and 87; thence with the line of Lot No. 87 N. 38-20 E. 160 feet to an iron pin on the Southwestern side of Brook Forest Drive West; thence with the Southwestern side of Brook Forest Drive West S. 51-40 E. 80 feet to the point of beginning.
