"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, purchased in consideration of \$4000.00, lot Section 3 of Orr Hill Street or Avenue, Piedmont Manufacturing Company Village. Purchased 8-1-50 from J. P. Stevens Co., Inc. and is the property located at #2 Orr Street, Piedmont, S.C. as recorded in Book #416, Page 387, County of Greenville, S. C.
