TO ALL WHOM THESE PRESENTS MAY CONCERN:

A. Q. Greene and Lurette B. Greene (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of --- Three Thousand Five Hundred and no/100--- DOLLARS (\$ 3,500.00--- ), with interest thereon from date at the rate of Six and one-half per centum per annum, said principal and interest to be repaid in monthly instalments of Forty and no/100--- Dollars (\$ 40.00 ) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Perry Avenue, in the City of Greenville, being shown as Lot No. 30 on a plat of Perry Avenue Annex, recorded in Plat Book A at page 878, and described as follows:

BEGINNING at a stake at the Southeast corner of Perry Avenue and a 15 foot alley and running thence with the Southern side of Perry Avenue, N. 74-20 W. 57 feet to a stake at corner of Lot 29; thence with the line of said lot, S. 13-15 W. 140 feet to a stake at Branwood Street; thence with the Northern side of Branwood Street, S. 74-20 E. 57 feet to a stake on said alley; thence with the Western side of said alley, N. 13-15 W. 140 feet to the beginning corner.

Being the same property conveyed to the mortgagors by Paul S. and E. Vernon Nelson by deed recorded in Deed Book 494 at page 260.
