And the said David L. Slice and Betty W. Slice agree to insure the house and buildings on said lot in the sum of not less than full insurable value and keep the same insured from loss and damage by fire, and assign the policy of insurance to the said J. C. Cox, Jr., his

and that in the event that the mortgagor shall at any time fail to do so, then the said J. C. Cox, Jr., may cause the same to be insured in his name and reimburse him for the premium and expense of such insurance under the mortgage.

And it is Agreed, by and between the said parties, that should legal proceedings be instituted for the collection of the debt secured hereby, then, and in that event, the said Mortgagee, his successors or assigns, shall have the right to have a Receiver appointed of the rents and profits of the above described premises, with power to forthwith lease out the said premises now if he should so elect, who, after deducting all charges and expense attending such proceedings and the execution of the said trust as Receiver, shall apply the residue of said rents and profits toward the payment of the debt secured hereby.
