NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents; the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Linwood Drive, near the City of Greenville, being shown as Lot No. 41 on a Plat of McSwain Gardens, recorded in Plat Book GG, Page 75, and described as follows:

BEGINNING at an iron pin on the Southern side of Linwood Drive at the corner of Lot No. 34, and running thence with the line of said lot, S. 16-22 E. 144.45 feet to an iron pin at the corner of Lot No. 33; thence with the line of Lots No. 33 and 32, S. 78-23 W. 115.8 feet to an iron pin at the corner of Lot No. 42; thence with the line of said lot, N. 10-00 W. 150.2 feet to an iron pin on Linwood Drive; thence with the Southern side of said Drive, N. 80-00 E. 45.2 feet and N. 84-04 E. 54.8 feet to the BEGINNING corner.

Being the same property conveyed to the Mortgagors by Frank P. Hammond by deed recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging of in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
