WHEREAS I, Peggy O. Freeman, of Greenville County, am well and truly indebted to Wooten Corporation of Wilmington

sum of Five Thousand, Four Hundred Eighty-One and 98/100 (\$5,481.98) Dollars, in and by my certain promissory note in writing of even date herewith, due and payable as follows: interest only to be paid in monthly instalments of \$ 27.41 each, beginning on the 1st day of May, 1962 and continuing on the 1st day of each and every succeeding month thereafter until the 1st day of April, 1981, then in monthly instalments of \$ 105.99 each, beginning on the 1st day of May, 1981 and continuing on the 1st day of each and every succeeding month thereafter until paid in full, said amortized payments to be applied first to interest and then to the principal balance remaining due from month to month, including.

with interest from date at the rate of six (6%) per centum per annum until paid; interest to be computed and paid monthly and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Peggy O. Freeman

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Wooten Corporation of Wilmington, its successors and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 193 of a subdivision known as Pineforest as shown on plat thereof prepared by Dalton & Neves, August, 1959, and recorded in the R. M. C. Office for Greenville County in Plat Book QQ, at pages 106 and 107, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Vine Hill Road, joint front corner of Lots Nos. 193 and 194, and running thence along the joint line of said lots, N. 16-42 E. 186.3 feet to an iron pin on the rear line of Lot No. 205; thence along the rear lines of Lots Nos. 205 and 206, N. 68-56 W. 91.7 feet to an iron pin on the rear line of Lot No. 191; thence along the rear lines of Lots Nos. 191 and 192, S. 19-12 W. 193.6 feet to an iron pin on the northeastern side of Vine Hill Road; thence along the northeastern side of Vine Hill Road, S. 73-18 E. 100 feet to the beginning corner; being the same conveyed to me by Wooten Corporation of Wilmington by deed of even date to be recorded herewith.

This is a second mortgage and is junior in lien to that mortgage executed to the First Federal Savings and Loan Association of Greenville, which mortgage is recorded in the R. M. C. Office for Greenville County in Mortgage Book 855, at page 263.

And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said mortgagee, its successors ~~Heirs~~ and Assigns, from and against me, my Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim the same or any part thereof.
