All that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, being known and designated as Lot No. 7 on plat of MAPLE ACRES, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "FF", Page 111.

Said lot fronts on the northerly side of Chastain Drive, 60 feet, is 257.1 feet on the westerly side, 171.0 feet on the easterly side, and is 177.0 feet across the rear.
