WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the eastern side of Pimlico Road, in the City of Greenville, being shown and designated as lot # 68, Section A on a plat of Gowar Estates, recorded in the RMC office for Greenville County in Plat Book QQ at Page 146-147, and described as follows:

BEGINNING at an iron pin on the eastern side of Pimlico Road, at the joint front corner of lots # 68 and 69, and running thence with the line of lot # 69, S. 76-41 E. 175 feet to pin, rear corner of lot # 67; thence with the line of lot # 67, N. 12-30 W. 180.2 feet to pin on Don Drive; thence with the southern side of Don Drive, N. 79-16 W. 80.9 feet to pin; thence with the curve of the intersection of Don Drive and Pimlico Road, the chord of which is S. 46-16 W. 41.9 feet to pin on Pimlico Road; thence with the eastern side of Pimlico Road, S. 13-19 W. 94.1 feet to the point of beginning.
