We, Dr. Roy M. Whitman and Dorothy Y. Whitman, Wife  
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRYON FEDERAL SAVINGS AND LOAN ASSOCIATION OF TRYON, N. C. All of that parcel or lot of land in Glassy Mountain Township of Greenville County, South Carolina, located in a development known as "Lake Lanier", being shown and designated as Lot No. 1059 on Plat No. 3, which Plat was prepared by George Kershaw, C.
