All that lot of land in the County of Greenville, state of South Carolina, shown and described as Lot No. 422, Block B, Woodland subdivision as shown on plat thereof recorded in plat book J pages 70-71 of the REC OFFICE for Greenville County, S. C.; said lot having a frontage of 51 feet on the southeast side of Mills Avenue, a depth of 194.2 feet on the northeast side, a depth of 188.2 feet on the southwest side and a rear width of 50 feet.
