WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

reference, in the sum of **"Twelve Thousand and no/100**

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, in **Gantt Township**, being known and designated as **Lot No. 4** of a subdivision known as **Kenmore Terrace**, recorded in the R. M. C. Office for **Greenville County** in plat book **XX** at page **7**, and having the following metes and bounds, to-wit:
