(hereinafter referred to as Mortgagor) SEND(S) GREETING

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township near the City of Greenville, on the eastern side of Old Grove Road, and having according to plat of the property of J. C. Black and Hazel K. Black, recorded in Plat Book PP at Page 122, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Old Grove Road, and running thence with the eastern side of Old Grove Road, N. 0-33 E. 187 feet, more or less, to branch; thence down the branch as a line N. 75-26 E. 258.1 feet to pin; thence S. 0-42 W. 144.5 feet to pin; thence S. 66-43 W. 271.8 feet to the point of beginning.
