To All Whom These Presents May Concern: We, Wilbur G. Knighton and

Julia J. Knighton, hereinafter called
the Mortgagor(s), SEND GREETING:

WHEREAS, the said Mortgagor(s) in and by their certain promissory note in writing, of even date with these Presents, are well and truly indebted to E. E. Hawkins

hereinafter called Mortgagee, in the full and just sum of
Fifty-five Hundred (\$5500.00) - - - - -DOLLARS,

to be paid as follows: \$50.00 on November 1, 1964, and \$50.00 on the first day of each month thereafter until paid in full, each of said payments to be applied first to interest and the balance to the principal, with the privilege of paying additional amounts on any payment date,

with interest thereon from date at the rate of six per centum per annum, to be computed and paid monthly, as stated above,

E. Hawkins and his heirs and assigns:
