if not sooner paid, shall be due and payable on the first day of August, 1995.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better  
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three  
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing  
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,  
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following-described real estate situated in the County of Greenville,  
State of South Carolina: on the northern side of Mayo Drive and being known and  
designated as Lot No. 221 of Paramount Park as shown on plat thereof recorded  
in the R. M. C. Office for Greenville County in Plat Book "W", at Page 57 and  
having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Mayo Drive at the joint front  
corner of Lots Nos. 220 and 221 and running thence along said Drive S. 64-00 W.  
70 feet to an iron pin; thence along the line of Lot No. 222 N. 26-00 W. 150 feet  
to an iron pin; thence N. 64-00 E. 70 feet to an iron pin; thence along the line of

assigns forever.
