NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot. No. 4 Block DD, of a subdivision known as Riverside, according to a plat thereof recorded in the RMC Office for Greenville County in Plat Book K, at page 261-264, and having, according to said plat, the following metes and bounds to wit:

BEGINNING at a stake on the south side of Colonial Avenue at the joint front corner of Lots No. 3 and 4, Block D and running thence along the south side of Colonial Avenue, S. 79-21 E. 50 Feet to the front corner of Lot No. 5, Block DD; thence along the line of that lot, in a southerly direction, 125 feet to the north side of a ten foot alley; thence along the north side of said alley, N. 79-21 W 50 feet to the rear corner of Lot No. 3; thence along the line of that lot, in a northerly direction, 125 feet to the beginning corner.
