MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, We, Golden Allen and Maggie Allen

(hereinafter referred to as Mortgagor) is well and truly indebted unto BARCO, INC.,

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Two Thousand Twenty Seven and 67/100 (\$2027.67)

Dollars (\$ 2027.67) due and payable in equal monthly installments of forty seven and 63/100 (\$47.63) Dollars, commencing the first day of September, 1965, and continuing each and every month thereafter on the first day for a period of forty eight (48) months and until paid in full and as more fully set forth in Real Estate Note dated this day,

with interest thereon from date at the rate of -six- per centum per annum, to be paid: as set forth in Real Estate Note.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and according to a revision of Lot No. 4 made by Ethan C. Allen, R.L.S., recorded in Plat Book ___ page ___ and having the following:

BEGINNING at an iron pin in Birdland Drive, which iron pin is 0.3 miles, more or less, to Woods Crossing Road, and running thence with Birdland Drive, N. 63-15 E. 50 feet to an iron pin; thence S. 26-45 E. 72 feet to an iron pin; thence S. 63-15 W. 50 feet to an iron pin; thence N. 26-45 W. 72 feet to the point of beginning and being that property conveyed to mortgagors by deed dated October 24, 1963, executed by Tommie Wright and Josephine Wright.

FOR VALUE RECEIVED the undersigned does hereby grant, bargain, sell and release unto NORTH AMERICAN ACCEPTANCE CORPORATION, 1252 W. Peachtree Street, N.W., Atlanta, Georgia, all its right, title and interest to the within mortgage and to the note for which said mortgage is given to secure, this 22nd day of July, 1965.
