TO ALL WHOM THESE PRESENTS MAY CONCERN: Polly P. & Carl H. Crisp

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Bank of Travelers Rest

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of One Thousand Sixty-Two

and 89/100 ----- DOLLARS (\$ 1,062.89 ),

with interest thereon from date at the rate of 6 per centum per annum, said principal and interest to be repaid:

Monthly installments of \$50.00 on the 23rd day of each month hereafter beginning August 23, 1965, until paid in full, with interest from date at 6% to be computed and paid semi-annually in advance.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Cleveland Township, being shown on plat of property of R. L. Osteen, recorded in the R.M.C. Office for Greenville County in Plat Book X at Page 20, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west bank of the Middle Saluda River, and running thence S. 65-15 W. 105 feet to stake; thence S. 2-15 W. 100 feet to stake; thence N. 65-15 E. 105 feet to point on the west bank of Middle Saluda River; thence ~~to the meanders of said River~~ N. 2-15 E. 100 feet to the point of beginning.

This being the same property conveyed to the mortgagors by deed of A. H. Simpson recorded in Deed Book 925 at Page 19.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
