TO ALL WHOM THESE PRESENTS MAY CONCERN: OMRIE A. HUGHES AND BLANCHE T. HUGHES

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S.
