TO ALL WHOM THESE PRESENTS MAY CONCERN: John E. Galloway

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of ----- Ten Thousand and no/100-----DOLLARS (\$10,000.00-----); with interest thereon at the rate of Six (6%)-----per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is Fifteen years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the northeastern side of Old Easley Bridge Road, and being shown as all of Lot No. 1 and a strip of land along the southeastern portion of Lot No. 2, on a plat of Geneva E. Arrowood, prepared by Webb Surveying and Mapping Company, June 17, 1965, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Old Easley Bridge Road at the joint corner of Lots Nos. 1 and 2, and running thence with line of Lot 2, approximately N. 30-00 E. 180 feet more or less to an iron pin in line of Lot No. 4; thence with the line of said lot, S. 55-13 E. 436 feet to an iron pin; thence S. 0-57 W. 216.4 feet to an iron pin in the line of Old Easley Bridge Road; thence with line of said lot, N. 55-13 W. 145.9 feet to the point of beginning.
