WHEREAS, the Mortgagor is well and truly indebted unto AIKEN LOAN & SECURITY
COMPANY

a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eight Thousand Seven Hundred Fifty and No/100 - - - Dollars (\$ 8,750.00-----), with interest from date at the rate of Five and One-Fourth per centum (5-1/4-----%) per annum until paid, said principal and interest being payable at the office of Aiken Loan & Security Company in Florence, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Seventy and 35/100 - - - - - Dollars (\$ 70.35-----), commencing on the first day of December, 1965, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of November, 1980.

ALL that certain piece, parcel, or lot of land, with improvements thereon, situate, lying, and being in Greenville County, South Carolina, known and designated as Lot 8, Woodfields subdivision, as shown on a Plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plats Book S, Page 7.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever.
