GREENVILLE COUNTY MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, Charles B. Springfield (with Annie L. Springfield as co-signer)

Office for Greenville County in Plat Book "EE" at page 75, reference to which is hereby made for a more complete description as to size, shape, metes and bounds.
