WHEREAS, the Mortgagor is well and truly indebted unto

organized and existing under the laws of North Carolina, hereinafter

securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All that piece, parcel or lot of land, with the buildings and improvements thereon,
situate, lying and being in the City of Greenville, County of Greenville, State of
South Carolina, being known and designated as Lot 22, Pleasant Valley, Section 1,
plat of which is recorded in the RMC Office for Greenville County, S. C. in Plat
Book P, at page 93, and having, according to said plat the following metes and
bounds, to-wit:

BEGINNING at an iron pin on the Northerly side of a concrete sidewalk along
Pleasant Ridge Avenue, joint front corner Lots 22 and 23; and running thence
N. 0-08 W. 160 feet to an iron pin; thence N. 89-52 E. 60 feet to an iron pin;
thence S. 0-08 E. 160 feet to an iron pin on the Northerly side of a concrete
sidewalk along Pleasant Ridge Avenue; thence along the Northerly side of said
sidewalk S. 89-52 W. 60 feet to an iron pin, the point of beginning.
