WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

reference, in the sum of Fourteen Thousand Five Hundred and No/100

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, shown and designated as Lot 28, Section 2 on a plat of Colonial Hills Sub-division recorded in the R. M. C. Office for Greenville County in Plat Book RR at Page 185, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Embry Street at the joint front corner of Lots 28 and 29 and running thence with the joint line of said Lots S. 5-55 E. 150 feet to an iron pin; thence S. 84-05 W. 100 feet to an iron pin at the joint rear corner of Lots 27 and 28; thence with the joint line of said Lots N. 5-55 W. 150 feet to an iron pin on the Southern side of Embry Street; thence with the side of said Street N. 84-05 E. 100 feet to an iron pin at the point of beginning.
