All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville, containing 1.23 acres, more or less, in East View School District, Oaklawn Township, having the following metes and bounds, to-wit:**

BEGINNING at an iron pin in the center of the Piedmont-Pelzer Road; thence running down said road 208 feet to an iron pin; thence in a Southwestern direction 265 feet to a ditch; thence along said ditch, 208 feet to an iron pin in ditch; thence along the line of E.
