ALL that certain piece, parcel or tract of land lying and being in Austin Township, Greenville County, South Carolina, being shown as the Margaret Boyd Tract on a plat of the property of Inez Burton by C. O. Riddle, R.L.S., dated September 12, 1964, recorded in Plat Book FFF at page 120 in the R.M.C. Office for Greenville County.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
