NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All ~~that~~ ^{those} pieces parcels or lots of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southwestern side of Elmhurst Road near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lots Nos. 28 and 29/ ⁸¹¹ as shown on a plat of Westcliffe, prepared by Piedmont Engineers & Architects, dated December 11, 1963, revised September 24, 1965, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book JJJ at pages 72, 73, 74 and 75, and having, in the aggregate, according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Elmhurst Road at the joint front corner of Lots Nos. 27 and 28, and running thence with the line of Lot No. 27 S. 57-00 W. 165 feet to an iron pin in the rear line of Lot No. 36; thence with the rear lines of Lots Nos. 36 and 37 N. 43-22 W. 111.8 feet to an iron pin; thence continuing with the rear line of Lot No. 37 and with the rear line of Lot No. 39 N. 42-08 W. 109.5 feet to an iron pin at the joint rear corner of Lots Nos. 29 and 30; thence with the line of Lot No. 30 N. 49-54 E. 200 feet to an iron pin on the Southwestern side of Elmhurst Road; thence with the Southwestern side of Elmhurst Road S. 36-16 E. 73 feet to an iron pin; thence continuing with the Southwestern side of Elmhurst Road S. 33-00 E. 170 feet to the point of beginning.
