All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, town of Fountain Inn, And shown as lot 22, Section "A", on a plat of Friendship Heights, recorded in the R.M.C.
