Biddle, Surveyor, dated October 21, 1920, the said plat being of record in Plat Book 117, page 117, Office of RMC for Greenville County, and have according to said metes, the following metes and bounds: BEGINNING at an iron pin at the southeast corner of property of the Grantor on the corner line of property now or formerly owned by L. P. Burdette line, and running hence along the said Burdette line, N. 1-47 1/2 W. 158.1 feet to a point on the Burdette line and the 3.4 acre tract; thence S. 85-48 W. 276 feet along the line of the 3.64 Acre Tract to a point along the line of said tract; thence S. 1-47 1/2 E. 158.1 feet along the line of Division of the front and rear one (1) acre tracts, to a point on the L.
