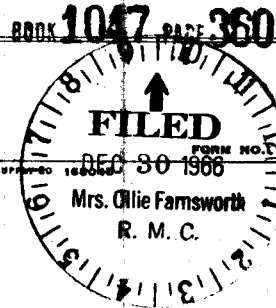

WHEREAS, we the said A. O. Carroll and Annie Lou Carroll  
in and by our certain note or obligation, bearing date the 21st  
day of December, A. D. 1966, are indebted

Six Hundred Twenty-Five and no/100ths (\$625.00)-----DOLLARS

~~conditioned for the payment of the full and just sum of~~, with interest thereon from date at  
the rate of seven (7) per centum per annum, payable in equal, consecutive,

delivery of these presents and receipt whereof is hereby acknowledged, have granted, bargained, sold and released,  
and by these presents do grant, bargain, sell and release unto the said H. S. Creech:

All that piece, parcel or lot of land being known and designated as Lots No.  
128 and 129 of Conestee as shown by a Plat thereof, made by Madison H. Woodward,  
Engineer, recorded in the R. M. C. Office for Greenville County in Vol. "T",  
at Pages 383 and 384; said Lots having the courses, distances, metes and  
bounds, to-wit: Beginning at an iron pin on West Pine Lake Circle at joint  
front corners of Lots No. 127 and 128 and running thence along the line of  
said Lot No. 127, S. 89-31 E. 213 feet to iron pin at back corner of Lot No.  
142; thence running with the rear lines of Lots No. 142 and 141, N. 0-29 E.  
120 feet to iron pin at back corner of Lot No. 130; thence running with the
