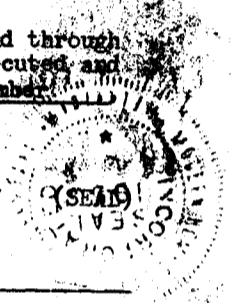
that certain Security Instrument (whether designated a Security Deed, Mortgage, Deed of Trust or otherwise) from Henry A. Williams

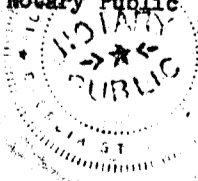
