WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **Eleven Thousand Nine Hundred and no/100-----** DOLLARS (\$ 11,900.00 ), with interest thereon at the rate of **Six & three-fourths** cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 20 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, shown as Lot 52 on Plat entitled Berea Heights, Section 3, recorded in Plat Book HHH at page 147 in the RMC Office for Greenville County, and having, according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northwestern side of Wardview Avenue at the joint front corner of Lots 52 and 53; thence with line of Lot 53, N. 40-40 W. 156.5 feet to iron pin at rear corner of Lot 49; thence with the line of Lot 49, N. 50-06 E. 100 feet to iron pin at corner of Lot 51; thence with line of Lot 51, S. 40-40 E. 154.7 feet to iron pin on Northwestern side of Wardview Avenue; thence with Northwestern side of Wardview Avenue, S. 49-20 W. 100 feet to the beginning corner.

Being the same property conveyed to Mortgagor by deed of R. W. Jones.
