C., said lot having a frontage of 80 feet on the northern side of Midway Road, a depth on the west side of 158 feet, a depth on the east side of 164.6 feet and a rear width of 80.3 feet. This is the same property conveyed to the mortgagors by deed of Ruby G. Wesson of Spartanburg County and same conveyed to Ruby G. Wesson by deed of Kenneth R. Mitchell recorded in Volume 719 at page 368 of the RMC Office for Greenville County.

To have and to hold, with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, unto said Mortgagee, provided always, and this instrument is made, executed, sealed and delivered upon the express condition that if the said Mortgagors shall pay in full to the said Mortgagee the above-described Note according to the terms thereof, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue.
