MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, Lloyd W. Gilstrap and James W. Fortescue, of Greenville County,

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Thirteen Thousand, Five Hundred and No/100----- (\$ 13,500.00 )

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate therein specified in installments of Ninety-One and 16/100----- (\$ 91.16 ) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 25 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 14 and part of Lot No. 13 of a subdivision known as Enchanted Forest as shown on a plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book YY, at Page 123, and is also shown on a plat of a revision of Lots 12 and 13, recorded in the R. M. C. Office for Greenville County in Plat Book BBB, at Page 17, and having, according to said plats, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Enchanted Circle at the joint front corner of Lots 14 and 15, and running thence with the joint line of said lots, S. 46-57 W. 143.6 feet to an iron pin; running thence with the rear line of Lots 14 and 13, S. 61-58 E. 207.5 feet to an iron pin; running thence along a line through Lot 13, N. 9-57 W. 144 feet to an iron pin on the southwestern side of Enchanted Circle; thence with the curvature of said Enchanted Circle, the chord of which is N. 55-16 W. 26.2 feet to an iron pin at the corner of Lots 13 and 14; thence continuing with the southwestern side of Enchanted Circle, N. 9-42 W. 50 feet to the point of beginning; being the same conveyed to us by J. L. Quinn Realty Co. by deed dated May 18, 1967 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 820, at Page 627.
