All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, on the northern side of Colonial Lane, Austin Township, shown as lot 9 on a plat of Colonial Acres, recorded in the R.M.C. Office for Greenville County in plat book "BBB", page 33, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern edge of Colonial Lane, at the joint front corner of lots 7 and 9 and running thence along the line of lot 7, S. 17-30 E. 242 ft. to an iron pin; thence S. 72-30 W. 188 ft. to an iron pin on the eastern edge of a 50 ft. street; thence along the edge of said street, N. 17-30 W. 217 ft. to an iron pin; thence with the curve of the intersection of said 50 ft. street and Colonial Lane, N. 27-30 E. 35.3 ft. to an iron pin on the southern edge of Colonial Lane; thence along the southern edge of Colonial Lane, N. 72-30 E. <sup>180 ft.</sup> to the point of beginning.
