(hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, about 3 miles Northwest of Greer, in Oneal Township, at the East intersection of Memorial Drive Extension and Valley Creek Drive, and having the following courses and distances, to-wit: Beginning at a White Oak and running thence N.22-49 E.39 feet to the South side of Valley Creek Drive, thence with the South side of Valley Creek Drive S.34-00 W.42 feet and S.55-00 W.173 feet, more or less, to a point in center of Memorial Drive Extension, thence with Memorial Drive Extension S.9-53 E.62 feet and S.15-53 E.100 feet to a point in Memorial Drive Extension, thence N.23-36 E.278 feet to the beginning point. This being a part of the property which was conveyed to mortgagor herein by E. G. Fuller by deed recorded in the R. M. C. Office for said County in Deed Book 623, page 234.
