Six ----- per centum (---6 %) per annum until paid, said principal and interest being payable
at the office of Cameron-Brown Company -----

in Raleigh, North Carolina -----, or at such other place as the holder of the note may
designate in writing delivered or mailed to the Mortgagor, in monthly installments of Ninety-six and No/100
-----Dollars (\$96.00 -----), commencing on the first day of

November -----, 19 67, and continuing on the first day of each month thereafter until the principal and
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor
in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described
property situated in the county of Greenville -----,
State of South Carolina;

ALL that piece, parcel or lot of land situate, lying and being on the southeastern side of Sherman
Lane near the City of Greenville, in the County of Greenville, State of South Carolina and
shown and designated as the property of Otis Davis by plat recorded in the R.M.C. Office for
Greenville County in Plat Book RRR at Page 19; said lot having such metes and bounds as shown
thereon.

Should the Veterans Administration fail or refuse to issue its guaranty of the loan secured by
this instrument under the provision of the Servicemen's Readjustment Act of 1944, as amended,
within sixty days from the date the loan would normally become eligible for such guaranty,
the mortgagee may, at its option, declare all sums secured hereby immediately due and payable.
