I, Bruce T. Foster

hereinafter called

the Mortgagor(s), SEND GREETING:

WHEREAS, the said Mortgagor(s) in and by **my** certain promissory note in writing, of even date with these Presents, **am** well and truly indebted to BANK OF GREER, GREER, S. C., hereinafter called Mortgagee, in the full and just sum of

NOW KNOW ALL MEN, That the said Mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor(s) paid by the said Mortgagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagee,

All that certain parcel or lot of land situated on the southeast side of Valley, about three miles northward from the City of Greer, Oneal Township, Greenville County, State of South Carolina, and being Lot No. 25 of VALLEYHAVEN, property of W. Dennis Smith, according to survey and plat by H.S. Brockman, Registered Surveyor, dated July 22, 1959, recorded in Plat Book TT, page 11, R.M.C. Office for Greenville County, and having the following courses and distances, to wit:

BEGINNING at an iron pin on the southeast side of Valley Creek Drive, corner of Lots Nos. 25 and 26 at a culvert, and running thence along the line of Lot No. 26, S. 37-30 E. 177 feet to a stake at the branch; thence down the branch as the line, to the corner of Lot No. 1; thence along the line of Lot No. 1, N. 37-30 W. 214 feet to an iron pin on the edge of Valley Creek Drive; thence along said drive, S. 45-00 W. 100.9 feet to the beginning corner.
