(hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being near the City of Greenville, Greenville County, State of South Carolina shown as Lot No. 131 on the East side of Pinefield Drive on Plat of South Forest Estates, made by Pickell & Pickell Engineers, August 29, 1955, recorded in the RMC Office for Greenville County, South Carolina in Plat Book GG, Page 181, and having, according to said plat, the following metes and bounds, to-wit:
